Change in issuance of <u>Student Pilot certificate</u>. 8710 certificate applications to be submitted (paper or IACRA) to the FAA which will then send the application to Transportation Security Administration for vetting before the FAA issues a "plastic" Student Pilot certificate to the applicant.
